WATER: There was a main waterline break on the evening of July 2, 2012 just east of Veka Drive on Route 588. The line was repaired that evening but the Township will have to replace some asphalt. The Township received a bid from A R Oliastro for \$6800. Alan Dambach motioned to authorize A R Oliastro to replace the asphalt that was damaged due to the waterline break on Route 588 at a cost of \$6800, Dean Davis seconded. ADAYE DDAYE

SEWAGE: The final draft of the NPDES Permit has still not been received by the Township.

ROADS: Paving of Petrie Road has been completed. The waterline at the West Road Bridge project is complete and has been tested. The gate still needs to be made and installed. Mr. Dambach is going to get prices to spray the weeds around the guide rails on the Township roads.

POLICE: The Police Report was submitted and approved as follows: Total hours worked: 183 hours, Mileage: 1142 miles, Traffic citations: 7, Total calls: 9, Mutual Aid calls: 2. The seat covers for the Ford Expedition have come. The Chief conducted 5 interviews for the Patrolman position. Alan Dambach motioned to advertise for a special meeting, Thursday, July 12, 2012, at 4:00 p.m., to hire a Police Officer. Alan Dambach motioned to purchase 3 no parking signs, Dean Davis seconded. PLANNING COMMISSION: Mrs. Freshcorn presented the Robert Rice Plan of Subdivision. Alan Dambach motioned to approve and sign the Robert Rice Plan of Subdivision, Dean Davis seconded. ADAYE DDAYE The Commission completed the definitions for the Zoning Ordinance.

ZONING: Building permits issued in the month of June to Thomas Meehan-house addition, Kevin Dambach-garage.

The Township is still trying to lease the Post Office property.
