ROADS: The bids for road work were opened. Pro Tech Asphalt: Veka Drive- 28,897.50, Householder Road- 18,731.80 for a total of 47,629.30, Youngblood Paving: Veka Drive- 27,358.50, Householder Road- 17,208.10 for a total of 44,566.60. Alan Dambach motioned to accept the low bid from Youngblood Paving of \$44,566.60 subject to the review by Engineer Hummel, Dean Davis seconded. The roadside spraying was resprayed in areas that needed it.

PLANNING COMMISSION: The Commission is working on updating the Zoning Ordinance and reviewing a Street Opening and Flood Plain Ordinance.

The Public Safety Building was discussed. Honeywell will likely give the Township land for the building but the Township must pay for the environmental study, survey and attorney fees. Mr. Dambach will get estimates on those fees. Dean Davis motioned to form a Public Safety Building Committee and appoint Fire Chief P J Moldovan, Police Chief Rudy Harkins and EMC Doug Rice to the Committee, Alan Dambach seconded. TGAYE ADAYE DDAYE Lonnie Vodenicker told the Board that Big Knob Fire Department will have two new trucks in 8 to 12 months. It was agreed that the new contract between the Township and Fire Department be a five year contract.

Greg Cooper is interested in taking down the dead ash tree on the Township property. The Township will need a release of liability.

The Secretary will get quotes for a copier, scanner, fax machine.
