

The regular monthly meeting of the Marion Township Supervisors was called to order at 4:00 p.m. on Monday, December 13, 2010 at the municipal building. Supervisors Thomas George, Alan Dambach, and Dean Davis were present. Also present were Philip Lope, Rudolph Harkins, Marilyn Zona, Elnora Freshcorn, and Doug Rice.

WATER: Alan Dambach motioned to adopt the Amendment to Ordinance 87-2, changing the billing rate for the public water system to \$7.00/1000 gallons and the minimum rate to \$7.00, Dean Davis seconded. TGAYE ADAYE DDAYE

SEWAGE: Mr. Kremer reported to Tom George that he had problems at the plant 2 weeks ago with chlorine levels but that the problem has been resolved.
