Question about the property at 2041 Route 68 that is for sale, interested buyers would like to raise pheasants. The interested party should put in writing to the Township what they are planning. Josh Graeff explained to the Supervisors that he is interested in purchasing the Launer Property at 1406 Route 588 and building a garage with a house above. Attorney Lope advised since it is a nonconforming property because it is less than an acre he must stay in the footprint of the trailer that is there.
