The Supervisors and Chief Harkins will meet with the Chief of the Northern Regional Police Department to get information on Police consolidation.

Marilyn Zona reported that the Norman Freshcorn property sold in June and the Township never received transfer taxes from the sale. She is working with the current property owners to have the taxes filed.

The Township will make Cardinal Midstream aware that Householder Road will need to be fixed when they are done with the pipe line work.

The Supervisors worked on the General Budget, completed the State Budget and worked on the Water Budget.
