Supervisors Thomas George and Dean Davis were present, Alan Dambach was absent. Also present were Mike Pszenny and Marilyn Zona.

Dean Davis motioned to appoint Thomas George temporary Chairperson, Tom George seconded. TGAYE DDAYE Dean Davis motioned to appoint Thomas George as Chairman, Tom George seconded. TGAYE DDAYE Thomas George motioned to appoint Dean Davis as Vice Chairman, Alan Dambach as Police Commissioner, and all three Supervisors as Roadmasters, Dean Davis seconded. TGAYE DDAYE

Tom George motioned to recommend to the Auditors that the Road master and Water operator rate of pay be increased by 4% and the use of a truck for water work remain at \$35.00/hour, Dean Davis seconded. TGAYE DDAYE

Tom George motioned to reappoint Marilyn Zona as Secretary Treasurer with a 4% increase in hourly rate, with the same holidays, sick days, personal days and 5 weeks vacation, Dean Davis seconded. TGAYE DDAYE

Thomas George motioned to have the Treasurers' Bond raised to \$300,000, Dean Davis seconded. TGAYE DDAYE

Dean Davis motioned to retain all appointed Officials: Police Chief-Frank Evanson, Assistant Chief- Mike Pszenny, Police Officers- Eric McPhilomy, Robert O'Neil, and Timothy Waibel, Clerk: Linda George, Zoning Officer- Marilyn Zona, SEO-Colleen Berg, Solicitor-Chris Reese, Engineer- William Hummel, Water Operator-Thomas George, Sewage Plant Operator-Paul Kremer, Water and sewage engineer- Gannett Fleming-Tom Thompson, Depositories- Wesbanco and PLGIT, Tom George seconded. TGAYE DDAYE Dean Davis motioned to appoint Joe Corraini as Alternate Sewage Operator, Tom George Seconded. TGAYE DDAYE

Dean Davis motioned for a 4% increase in wages for the Police officers, Clerk, Janitor, Planning Commission members, Planning Commission Secretary, Zoning officer, Sewage plant operators, and Recyclers, Tom George seconded. TGAYE DDAYE

Dean Davis motioned to appoint William Brown as Chairman of the Vacancy Board, Tom George seconded. TGAYE DDAYE

Dean Davis motioned to reappoint Connie Johnston to a three year term on the Zoning Hearing Board, Tom George seconded. TGAYE DDAYE
