Dean Davis motioned to appoint Thomas George as Chairman, Alan Dambach seconded. TGAYE DDAYE ADAYE Alan Dambach motioned to appoint Dean Davis as Vice Chairman, Alan Dambach as Police Commissioner, and all three Supervisors as Roadmasters, Dean Davis seconded. TGAYE DDAYE ADAYE
