Dean Davis motioned to appoint Thomas George temporary Chairperson, Tom George seconded. TGAYE DDAYE Dean Davis motioned to appoint Thomas George as Chairman, Tom George seconded. Dean Davis motioned to retain all appointed Officials: Police Chief-Frank Evanson, Assistant Chief- Mike Pszenny, Police Officers- Robert O'Neil, Timothy Waibel and Andrew Niederlander, Clerk: Linda George, Zoning Officer- Marilyn Zona, SEO-Colleen Berg, Solicitor-Chris Reese, Engineer- William Hummel, Water Operator- Thomas George, Sewage Plant Operator-Paul Kremer and Joe Corraini, Water and sewage engineer- Gannett Fleming-Tom Thompson, Depositories- Wesbanco and PLGIT, Tom George seconded. Dean Davis motioned for a 4% increase in wages for the Police officers, Clerk, Janitor, Planning Commission members, Planning Commission Secretary, Zoning officer, and Recyclers, the Sewage Plant Operators will remain the same, Tom George seconded. TGAYE DDAYE

Tom George motioned to appoint William Brown as Chairman of the Vacancy Board, Dean Davis seconded. TGAYE DDAYE

Tom George motioned to reappoint Doug Rice to a five year term on the Planning Commission, Dean Davis seconded. TGAYE DDAYE
